

GENERAL SALE CONDITIONS

The reservation only takes effect after the receipt of the deposit and of the contract form filled with your signature, and after the direction has approved it. A written confirmation will be sent.

Deposit

For the rental of a mobile home a deposit corresponding to 30% of the amount of the rental + administration fees € 22 (€10 in middle and low season).

For the rental of a pitch a deposit corresponding to 30% of the amount of the rental + administration fees € 16 (high season only).

The deposit is not refundable.

The balance is payable on your arrival.

Guarantee

For the rental of a mobile home a guarantee of € 200 (not boxed) is required by arrival. It will be given back according to the rental inventory and the behaviour during the stay on the site. Any damaged furniture or object during the stay must be declared on the reception.

A swipe card for the barriers at the entrance allowing you the access to the campsite with your car will be handed to you against a guarantee of € 40 (not boxed) recovered after restitution of the card. Without this card you cannot enter or leave the campsite outside the opening hours of the reception.

Stay

During high season, weekly rentals of mobile homes are made from Saturday 4 p.m. till next Saturday 10 a.m.. During middle and low season, week-end rentals are made from Friday 18 p.m. till next Sunday 18 p.m.. For any other period, please contact us.

Rental for a pitch begins at 12 noon and end the following day at 12 noon. Otherwise one day additional will be invoiced.

Seasonal packages begin on May 1st and end on September 30th. The payment of the stay is divided in two parts: 50% by arrival and the balance on July 30th.

- Prices include the free unlimited access to the opened activities of the leisure park during the stay.
- A pitch or a mobile home cannot be occupied by more than 6 persons. Neither the reservation nor the hiring contract may be transmitted to another person without the approval of the direction. The name of every person must be written on the hiring contract.
- On your arrival straps (one per person on the contract) allowing you the access on the campsite and to the leisure park will be handed to you: you have to wear them during all the stay and give them back at the departure.
- Every visitor has to introduce himself at the reception as soon as he arrives. A daily charge will be applied.
- Only one vehicle per pitch is allowed. Extra vehicles have to be parked outside.
- The pitch or the mobile home has to be left clean. Otherwise the direction may keep the caution or one part of it.
- Every person under 18 must have a written and signed parental authorization.
- Pets are accepted. They should be kept on a lead and be clean. A daily charge is applied and you must be able to prove the vaccinations.
- Our pitches are equipped with European sockets. Please have an adapter if necessary.

No discount will be given in case of late arrival or early departure. The pitch/mobile home becomes free 24 hours after the previous time of arrival in case of no written notification of it and the whole cost of the previous stay must be paid.

Cancellation

The following will be retained:

- If you cancel more than 30 days before the specified arrival date: the administrations fees and 30% of the cost of the stay will be kept.
- If you cancel less than 30 days before the specified arrival date: the administrations fees and 100% of the cost of the stay will be kept.

Our prices don't include any cancellation insurance. We recommend you to take one out.

Responsibility

The campsite is not responsible in case of loss, theft or any damage, during or following the stay. For your own safeguard, you should take an insurance covering these risks and including personal liability. Children are under parents' responsibility.

In case of any trouble of your fact, the direction may expulse you, without refund.

Each person coming into the campsite has to respect the interior rules. They can be read at the reception and are at your disposal.
